

# RPTO - Registration Requirements for Train the Trainer (TTT) Course - Small Class As per DGCA Guidelines

# **Eligibility Criteria**

"A valid Remote Pilot Certificate (RPC) in the applicable category and class is required at the time of enrollment."

The applicant must possess a Degree from a University/Institute recognized by UGC/AICTE or equivalent, or hold a valid PPL (Private Pilot License), CPL (Commercial Pilot License), AME (Aircraft Maintenance Engineer) License, ATC (Air Traffic Controller) License, or a 3-year Diploma in a technical subject from a recognized institute

Age limit: 18 - 65 years

Proficient in English (Read / Write / Speak)

Should have teaching aptitude and in-depth drone operational knowledge

## **Identity Proof Guidelines**

- Remote Pilot Certificate (RPC) Valid and issued by a DGCA-authorized RPTO
- Educational Qualification Certificate
- 1. Degree or PPL / CPL / AME / ATC License or 3-year Technical Diploma
- 2. Final Year Marksheet

### Secondary ID (Submit any one):

- Passport

## **Important Notes**

- All documents must be clear, legible, and properly named in soft copy
- Incomplete submissions may delay or disqualify registration
- Minimum 18 years, 65 and Below 65 years
- Mobile number and email ID must be linked with the Aadhaar.
- Candidates will be evaluated based on written tests, simulator performance, and practical flight demonstrations in accordance with DGCA standards.
- During the TTT course, candidates will undergo evaluation through written tests, simulator sessions, and practical flight demonstrations as per DGCA guidelines.

- 4. Do not have any defect or deformity or loss of member which would interfere with the efficient performance of his/her duties as a RPA pilot.
- 5. Able to readily distinguish the VIBGYOR colours and not suffer from Night Blindness.
